- Writing sample from first semester legal writing course (original student work product – see guidelines below):
  - Please submit only legal brief or research memoranda for your writing sample; scholarly articles will not be permitted
  - Please limit your writing samples to no more than 15 pages
  - Please submit a cover sheet with your writing sample. In the cover sheet, please: (a) explain the assignment that generated the sample; (b) explain what sections, if any, you omitted from the sample to meet the 15-page limit; and (c) identify any persons who assisted you in drafting it.
